6) Director's report

DISCUSSION: Diane presented Director's report. Diane gave dates of Art and Music show. No school on April 7 or 10. Early Childhood Tea on April 14. Enrollment stands at 151, dropped a few since last meeting. Intent to return numbers are high. Five responses outstanding. There will be a lottery just for the wait list. All openings will be filled with preferential sibling applicants. District visit today re: third grade literacy. No changes to site. Faculty evaluations have been ongoing. Diane will have contracts to review in April. One AC unit died in Juniper. Taylor gave a \$7,000+ estimate to replace it. Billy Knight has been working on getting playground mulched and is obtaining two estimates.

7) Committee Reports

-- Financial committee (liason: Burt)

DISCUSSION: Burt presented financial committee report. Cash position is better than it was last month. Cash balance is greater than last month. Burt presented forecast budget for 2023-2024. The decision must be made as to whether the staff and teacher salary increases should be 4% or 8%. Jason said that the District insists that the FTE numbers fully cover the proposed salary and retirement expenses. The Board will have a special meeting next week to give the board time to make sure those numbers work and then decide on what level of raise to give to the salary and staff. The special meeting will be held on Thursday, April 6, 2023 at 6:00 pm.

-- Fundraising committee (liason: Tristan): Donations and Sponsorships

-- Grant writing work group

DISCUSSION: Tristan presented her report. The fundraising committee has broken into a grants and business fundraising committees and wants to add a corporate sponsorship committee. The committee will be hosting a grant writing expert to advise the committee on April 4, 2023 which will be open to the public. We have 19 current sponsors which Tristan wants to invite to the Asian festival. There is an Oyster roast on Saturday 4-7. Tristan asked for people with kids in the school if they can give testimonials. The committee has a videographer coming in to make a video about the school. Tristan asked the board to let her know if they know any businesses that can sponsor the school. Jason gave an update on the grant writing group.

DISCUSSION: Andres Kerllenevich gave report on the new facility search committee.

The landlord has replaced downspouts and gutters on 7 William Street. They are working on repairing a different part of the main building. They are discussing having an engineer make a structural report that the landlord will be responsible for repairing.
